Correlations to groundwater protection zones according to Czech § 30 Water Law (http://eagri.cz/public/web/file/10629/The_Water_Act.pdf) are as follow:

No restrictions to the use of shallow geothermal corresponds to area without defined groundwater protection.

Potentially restricted use of shallow geothermal energy corresponds to Water Law protection zone of degree II.

Protected area unsuitable for shallow geothermal use corresponds to Water Law protection zone of degree I.
